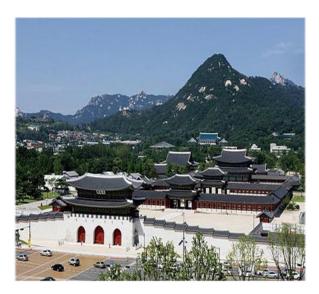


Figure 2. Gyeongbokgung palace, Seoul.
