Nulli vendemus, nulli negabimus aut differemus rectum aut justiciam." (Clause. 40).

The Universal Declaration on the Human Rights took over the Magna Carta has to say,

"Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world,

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law, Whereas it is essential to promote the development of friendly relations between nations," in a preamble.

"Whether we consider natural reason, which tells us, that men, being once born, have a rights to their preservation, and consequently to meat and drink, and such other things as nature affords for their subsistence But this beings supposed, it seems to some a very great difficulty how any one should ever come to have a property in any thing: I will not content myself to answer, that if it be difficult to make out property, upon a supposition that God gave the world to Adam and his posterity in common, it is impossible that any man, But I shall endeavour to show how men might come to have a property in several parts of that which God gave to mankind in common, and that without any express compact of all the commoners". (Second Treaties, sect. 25).

His words are still many implications today. Works of art that we see is the evidence.

4. Conclusion

Type Arts and human rights have helped each other's advancement consciously and unconsciously. In occasion, they awakened mundane political order when it crossed over the line of a moral law which it should not, and on other occasions, they become the source of imposing an order on the move of god, universe, and nature.
